CONDITIONS FOR FINANCIAL SUPPORT

Please read carefully the conditions below so that you are aware of your obligations.

1.
 - a. You should have reached State or National level by representing Palm Beach Currumbin State High (PBC) through District and/or Regional representative processes.
 - b. You have been chosen in an Australian team to travel overseas in one of PBC's sport excellence sports but not through the District and or Regional representative process
2. Your behaviour, attitude and effort at school should be such that it warrants your being a representative of PBC.
3. As a representative of PBC, your commitment and behaviour while away should be of a high standard in keeping with the values and reputation of PBC.
4. Your application must be completed in full and supported by copies of Queensland School sports official letter outlining the compulsory levies to be paid with a copy of your receipt of payment, plus a brief letter explaining in your own words, why your application should be considered by the P&C Executive Committee.
5. Other financial support for travel costs and related sponsorships must be fully disclosed with your letter of application.
6. Your application must be supported and signed by the Head of Department Sports Excellence. Only applications recommended and submitted by the PBC Head of Department will be considered by the P&C Executive Committee.
7. The P&C Executive Committee will take into account other P&C commitments and objectives when assessing applications for student support, and reserves the right to accept or decline applications, and or vary the amount of financial support.
